- 1) All the rules made by Government in Education Department in this regard shall be followed by the Management.
- 2) The Management shall provide infrastructure as per the norms prescribed.
- 3) The Management shall not collect any donation from the students or their parents/guardians and collect only fees prescribed by Government from time to time as per the provisions of the Andhra Pradesh Government Educational institutions (Abolition of Capitation Fee) Act, 1984 or as prescribed by the CBSE or state as the case may be.
- 4) The Management shall follow the traffic and safety guidelines indicated by the Police, Fire Services and Transportation Department from time to time. The instructions issued by circular No.21748/D1/97 dated 16-02-1998 and No.PRE-2008/506/11/1 dated 14-07-2011 & other orders of transport department for safe transportation of school children should be scrupulously followed. The management shall provide fire protection arrangement as prescribed in the National Building Code of India. Part-IV-Fire 1997 and there are amendments made from time to time.
